## Note 1: 2020 Subscription Rates

### (a) Manufacturer:

Annual Turnover (£)	Annual membership fees
£0 - £ 350,000	£500 per annum for the first two years of membership, providing no previous application for membership has been made and approved. Otherwise, the minimum subscription of £850 applies (+ VAT)
£350,001 - £ 2 million	£850 plus 30 pence per £ 1,000 of turnover in excess of £350,000 (+VAT)
> £2 million – £15 million	£1,345 plus 11.5 pence per £1,000 of turnover in excess of £2 million (+VAT)
> £15 million - £100 million	£2840 plus 55 pence per £1,000 of turnover in excess of £15 million (+VAT)
>£100 million - £225 million	£49,590 plus 50 pence per £1000 of turnover in excess of £100 million (+VAT)
>£225 million and above	£112,090 plus £23 per £million of turnover in excess of £225 million (+VAT)

(c) Factor: 50% of Manufacturer fee (+ VAT). This reduction only applies to turnover amounts above the minimum subscription rate i.e. £850 (+ VAT)

## Note 3: Membership Terms

- Membership benefits will not commence until subscription payment is received and Council approval gained.
- Under the terms of the Constitution the Executive Council may cancel the Membership of any member whose subscription remains unpaid three months after payment has been demanded.
- **RESIGNATION OR TERMINATION OF MEMBERSHIP (Articles of Association Section 12): "A member may resign his membership by six months' notice in writing to the Secretary, but shall remain liable for any subscription due from him at the date of expiration of such notice." The subscription year is from 1 January to 31 December.**
